- 1. Tommystock (hereinafter referred to as the "event") will be held **July 26-28 2019** regardless of weather conditions.
- 2. Event Hours: Friday, July 26 3-9p, Saturday, July 27 12p 9p Sunday, July 28 12a – 4p
- 3. A fully executed application including all required documents and fees must be received by July 1, 2019.
- 4. Event move-in day is Friday, beginning at 12p. The "event" will assign your location. Vendors must park in the designated areas only & during event days.
- 5. Vendors must be open for business from the start of the event, until closing time each day.
- 6. Vendors will supply proper power cords, subject to the "event's" approval. You will be responsible for all electrical cords leaving your unit, covering them securely with electrical tape. All generators used or needed must be noted on your application.
- 7. *Food Vendors Only*: All food vendors must provide a valid Oakland County Health Department temporary food permit or STFU. A copy of the paid permit to be provided to the event by July 1, 2019. Failure to supply health permit will result in termination without refund.
